under Right to Information Act, 2005

Sir,

This has reference to your online RTI Appeal made vide Registration No. NCSHQ/A/2017/60004 dated 02.07.2017 against the reply made by CPIO, BITM, Kolkata vide letter no. BM-49(85)/L/RTI/2017 dated 01.07.2017 in response to your RTI Application No. NCSHQ/R/2017/50019 dated 03.06.2017.

I have gone through the reply of the CPIO, BITM, Kolkata dated 01.07.2017. The CPIO, BITM, Kolkata has rightly furnished the information as 'nil' against your specific query "Actual date of disbursement of arrear DR of Director, BITM", since the Dearness Relief (DR) is not applicable to the regular employee. Director, BITM, being the regular employee, is disbursed **Dearness Allowance (DA), and not Dearness Relief (DR)**. However, if your query is "Actual date of disbursement of **arrears DA** of Director, BITM", the requisite information on the same together with the other query is furnished below:
