The reply to your queries is furnished below:

Sl. No.	Query	Reply
01.	What are the concessional/discount admissible to senior citizens for visiting Monuments/Museums?	Presently, no concession/discount is available for the senior citizens to visit this Museum.
02.	Is there a separate window or queue to senior citizens to get the entry tickets especially at World Heritage Monuments?	No separate ticket counter window or queue is as such earmarked for the senior citizens. However, care is taken in order to avoid delay in issuing the tickets to the senior citizens.
03.	Are the proper wheel chairs available to the visitors who cannot walk or climb?	Yes.
04.	Is there any alternative provision for senior citizens or disabled persons where the steps are high and not accessible?	Yes. Ramps are constructed for them. Besides, they can use wheel chair and elevator.
05.	Are proper toilet facilities or drinking waters provided which is accessible to senior citizens?	Yes. Specially made unisex toilet is there for differently able persons.


