Based on the directives received from the Ministry of Culture, Government of India from time to time followed by NCSM Orders regarding preventive measures to be taken to contain spread of CoVID-19 pandemic, various orders were issued by BITM regulating attendance of employees to office. The employees who could not attend office due to imposition of lockdown/restrictions, were advised to do work from home subject to the condition that they should be made themselves available on telephone and other electronic means of communications at all times and should attend office, if called for any exigency of work; The performance of such employees were monitored by respective sectional heads of BITM and its satellite units.
