**Details of advertisement :**

Online applications are invited from the eligible candidates for appointment to the following posts. Number of vacancies may increase in BITM, Kolkata / BSC, Bardhaman / NBSC, Siliguri / DSC, Digha / DSC, Purulia :

- (1) Technician 'A' (Fitting) : 01 post (Reserved for EWS) at Digha Science Centre & National Science Camp, Digha**
- (2) Technician 'A' (Carpentry) : 01 post (Reserved for EWS) at District Science Centre, Purulia**
- (3) Technician 'A' (Electrical) : 01 post (Reserved for EWS) at North Bengal Science Centre, Siliguri**

**Disclaimer :**

- (i) Benefits of reservation **under EWS category** can be availed upon production of an "Income and Asset Certificate" issued by a Competent Authority in the format prescribed by Government of India for the **Financial Year 2020-21 and valid for the year 2021-22.**
- (ii) ***The candidates who already uploaded their Valid EWS Certificates against the advertisement No. 1/2022 in connection with recruitment to the above mentioned posts need not apply further.***

**Pay Matrix :** `19,900-63,200/- Level-2; Basic Pay `19,900/-. Total emoluments is `29,048/- per month for DSC, Digha and DSC, Purulia. `30,848/- per month for NBSC, Siliguri.

**Essential Qualification :** (i) SSC or Matriculation with certificate from ITI or equivalent in relevant discipline; (ii) Candidates must have one year experience after obtaining the certificate for course duration of two years. For candidates obtaining certificates of one-year course duration, two years relevant experience after obtaining the certificate shall be required.

**Age limit :** 35 years as on **19.04.2022.** for each of the posts. Age relaxable for reserved categories of candidates as per Govt. of India Rules.

**Application Fee :**

- a) Fee payable : `200/- (Rupees Two hundred only)
- b) Women candidates, Person with Disability (PwD) and Ex-Servicemen (ESM) eligible for reservation are exempted from payment of fee.

- c) Fee can be paid through BHIM UPI, Net Banking or by using Visa, Mastercard, Maestro, RuPay Credit or Debit card.
- d) Online fee can be paid by the candidate up to **24.04.2022**.
- e) Candidates who are not exempted from fee payment must ensure that their fee has been deposited within due date. Applications which remain incomplete due to non-receipt of fee will be **SUMMARILY REJECTED** and no request for consideration of such applications and fee payment after the period specified in the details of advertisement shall be entertained.
- f) Fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection.

**How to apply :**

- a) Applications are required to be submitted in online mode only with **self attested scanned copies** of all certificates/testimonials/relevant documents in JPEG/JPG format (upto 200 KB) at the official website **[www.bitm.gov.in/recruitment](http://www.bitm.gov.in/recruitment)**.
- b) In the online Application Form, candidates are required to upload the scanned colour recent passport size photograph in JPEG/JPG format (upto 100 KB) and scanned signature (upto 100 KB).
- c) Last date for submission of online applications is **19.04.2022**.
- d) Candidates are advised in their own interest to submit online applications much before the closing date and not wait till the last date to avoid the possibility of disconnection/inability or failure to login to the BITM website on account of heavy load on the website during the closing days.
- e) Office will not be responsible for the candidates not being able to submit their applications within the last date on account of the aforesaid reasons or for any other reason beyond the control of the office.
- f) Before submission of the online application, candidates must check that they have filled correct details in each field of the form. After submission of the online Application Form, no change/correction/modification will be allowed under any circumstances.
