

SPECIAL TERMS & CONDITIONS:-

The following points are to be noted by the tenderers at the time of tendering for the “*External & Internal Wiring & Cable laying work at District Science Center, Digha.*”

1. Tenderers should visit the site before quoting the rate to understand the nature of work and condition of the site. Agency should personally confirm the nature, scope, purpose, tolerance limit, accuracy, dimensions etc. of the work as per the site conditions related to height, shape, and design etc. of the building and the place/location of work.
2. The rates shall be quoted inclusive of all materials, **wastage**, labour, shifting/lifting charges, **taxes & duties etc.** required for this job and the agency also needs to bring & supply all the tools, tackles etc. for successful completion of the work. No additional payment shall be made for this purpose.
3. **The work shall be required to carry out without obstructing the visitors’ movements and may also be required to carry out beyond office hours (if required) for which no additional payment shall be made.**
4. The quoted rate will be applicable for working upto any height/level, no extra/ separate payment will be considered on account of this.
5. No additional payment shall be entertained for any curved/sloped/ribbed/odd shapes and the rates shall be comprehensive for all conditions of works and shall be paid according to the rates quoted.
6. Successful tenderer will be required to submit the certificates of the materials brought at site, as and when required/asked by the Engineer concerned. All the materials must be got approved from the Engineer-in-Charge before supplying at site.
7. Necessary surface preparation to be done/made as per the requirement and instruction of Engr-in-Charge, and no extra payment will be made on this account.
8. The work is to be carried out after following all respective precautionary measure and safety rules. Expenditure towards insurance coverage for the labourers working at site has to be included in the rate. **Insurance certificate to be submitted prior engagement of their workmen to.**
9. Necessary staging and/or scaffolding/hanging, if required, to be erected at the cost of the contractor. No extra payment shall be made for this.
10. Statutory deduction shall be made in the bill e.g. Income Tax, Labour Welfare Cess etc.
11. The electricity arrangement for work should be arranged at own cost.

12. In case any damages occurred during the period of execution of work, the same has to be mended in good condition matching with existing one.
13. The successful bidder has to make insurance coverage from any Nationalised Insurance Company for their workmen & submit the same to authority of BITM before commencement of work, which is mandatory. No extra payment shall be made for the purpose.
14. Contractor has to submit all the test reports prior and after installation of cables, panels and ground earthings etc.
15. The Agency has to cooperate with other contractors working within the same premises and has to instruct strictly not to create any hindrance to others.
16. Contractor has to submit the wireman license and supervisor license issued by the State Government Authority before starting the work.
