Q.1	I, Shri Dibbendu Bain, Ex-employee of Birla Industrial & Technological Museum (A Unit of NCSM), An Autonomous Body under Ministry of Culture, Govt. of India. I served this museum from 09.03.2018 to 20.09.2024 and resigned on personal ground. Therefore, I request to the Competent Authority to clear all of my dues viz, DA arrears, EL encashments and Gratuity. In this regard, the authority replied via e-mail on 18.11.2024, that I am ineligible for gratuity because I resigned on personal ground. In view of above, I find an order, that is called Payment of Gratuity Act, 1972 and I am eligible for this. Therefore, I request you please give me appropriate order in this regard.	CCS (Pension) Rules, 1972 and CCS (Payment of Gratuity under National Pension System) Rules, 2021 regarding your ineligibility for Gratuity payment on resignation may be referred.
