- Call letters have already been sent by E-mail & Speed Post to the shortlisted candidates as per the list given above at their e-mail id & address mentioned by them in the online applications. The candidate who did not receive call letter through speed post and if his/her name appears in the list, he/she may appear in the Trade Test as per the above schedule, subject to production of **e-mail copy of call letter and valid photo identity proof alongwith 02 recent coloured passport size photographs**. Admission of the candidates to the Trade Test shall be strictly on production of the **following documents in original** for verification:

1. Call letter;
2. Proof of Identity viz. Aadhar Card/PAN Card/Voter ID/Passport/Driving License etc;
3. Documents towards proof of date of birth (Birth certificate/Admit card or certificate of SSC or Matriculation);
4. SC/ST certificate issued by the Competent Authority in the prescribed Central Govt. format. *Certificate in any other format would not be considered*; OBC certificate with valid Non-Creamy Layer Certificate valid for 2024-2025, issued by the Competent Authority in the prescribed Central Govt. format. *Certificate in any other format would not be considered*; Income and Asset Certificate for EWS candidate issued by the Competent Authority in the prescribed Central Govt. format for the Financial Year 2023 – 2024 and valid for the year 2024 – 2025. *Certificate in any other format would not be considered*;
5. Certificates/mark sheets of all educational & technical qualifications [SSC or Matriculation and ITI passed out Certificate in the relevant discipline (Electronics)];
6. Experience Certificate in the relevant discipline (Electronics) strictly in the pattern mentioned below:  
The Experience Certificate should clearly state your designation, period of service in the particular organization, nature of duty/work assignment(s) and the pay. The working experience certificates should be on the organisation's letter head, bearing the Date of issue. Pay slips/Office orders/Appointment orders or any other documents shall not be considered as proof of working Experience. The period of experience in the relevant discipline **i.e. Electronics** must be gained after the date of acquiring the minimum qualification prescribed for the post and before the closing date of submission of online application i.e. 12.03.2025 ;
7. If already working in Government, Semi-Government, Autonomous Organisations, Statutory Bodies and Public Sector Undertakings, on a regular/permanent post **or** on Contractual/Ad-hoc basis, **No Objection Certificate**, duly signed by the present employer;
8. NO TA will be paid to candidates appearing for the Trade Test. However, outstation SC/ST candidates will be reimbursed railway/bus fare by direct shortest route as per rules on production of to & fro tickets in original. Candidates are required to submit filled in prescribed form, which will be provided from our end on the date of Trade Test, alongwith the requisite bank details.
9. If any documents/certificates furnished are in a language other than Hindi or English, a transcript of the same, duly attested by a Gazetted Officer or Notary, is to be produced;

**NB :**

- *In case the information provided by the candidate is found to be false or the material facts are concealed by the candidate at any stage i.e. at the time of appearing in the Trade Test and/or after his/her joining in the Council, if selected, the candidature shall be cancelled forthwith and his/her service shall be terminated, if appointed.*
- *In case at any later stage it is found that the Marksheet(s)/Certificate(s) have been issued from an unrecognized/unauthorised institute/university/ Boards/authority, the candidacy or appointment will be liable to be rejected or cancelled, respectively.*
